# **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The USGS topographic map, NWI map, Google Earth Pro aerial imagery, and information provided by the property owner shows the site's overall 99-acres is comprised of approximately 97-acres of uplands (including two man-made ponds constucted within the uplands) and an approximate 2-acre isolated wetland (the isolated wetland is addressed in a separate NWK-2016-00067 AJD Form). The closest three-dot drain to the propoerty exists approximately 0.25-miles north (downgrade) of the site and overland sheet flow may eventually drain some of the property to this location. According to information provided by the property owner, the circular features within the property boundary shown on the NWI map (specifically near the center of the property) are rock and brush piles that have been farmed around with recent rowcrop production. Regarding the two man-made ponds, approximately 0.4 total acres, constructed in uplands within the northern portion of the property, they meet the criteria found in the preamble to the November 13, 1986, Rules and Regulations (Volume 51, No. 219, page 41217) of features not considered to be a water of the United States [(c) Artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing. (d) Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons. (e) Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States (see 33 CFR 328.3(a)).].
