This is in response to your emails, dated January 20 and 21, 2016, for a jurisdictional determination request on a site proposed for industrial development. The site, approximately 99-acres, is located in Sections 27 and 34, Township 29 north, Range 23 west, Greene County, Missouri. The request has been assigned Regulatory File No. NWK-2016-00067. Please reference this file number on any correspondence to us or to other interested parties concerning this matter.

In accordance with the December 2, 2008, National Guidance of Clean Water Act jurisdiction, this letter contains two approved jurisdictional determinations for the aforementioned 99-acre site. Each jurisdictional determination is valid for a 5-year period from the date of this letter unless new information warrants revision of the determination (or determinations) before the expiration date. The determinations document two areas at the site, an isolated wetland and uplands, which are not regulated by the Corps of Engineers (Corps). If you object to one or both of the determinations, you may request an administrative appeal under Corps regulations at 33 C.F.R. Part 331. Enclosed you will find two Notification of Administrative Appeal Options and Process and Request for Appeal (NAO-RFA) forms. If you request to appeal one or both of these determinations, you must submit a completed NAO-RFA form to the Northwestern Division Office at the following address:

In order for an NAO-RFA to be accepted by the Corps, the Corps must determine that it is completed, that it meets the criteria for appeal under 33 C.F.R. Part 331.5, and that it has been received by the Division Office within 60 days of the date of the NAO-RFA. Should you decide to submit an NAO-RFA form, it must be received at the above address within 60 days of this

letter. It is not necessary to submit an NAO-RFA form to the Division Office if you do not object to the determinations in this letter.

In the event that you disagree with an approved jurisdictional determination and you have **new information** not considered in the original determination, you may request reconsideration of that determination by the Corps District prior to initiating an appeal. To request this reconsideration based upon new information, you must submit the completed NAO-RFA form and the new information to the District Office so that it is received within 60 days of the date of the NAO-RFA. The Corps has jurisdiction over all waters of the United States. Discharges of dredged or fill material in waters of the United States, including wetlands, require prior authorization from the Corps under Section 404 of the Clean Water Act (33 USC 403) and /or Section 10 of the Rivers and Harbors Act of 1899 (33 USC 403). The implementing regulations for these Acts are found at 33 C.F.R. 320-332.
